2. The full amount of school fees shall immediately become due, owing and payable and shall be collectable upon my failure to pay any one instalment on the due dates unless prior written arrangements have been made with the Governing Body.
3. Interest shall be levied on unpaid accounts at 5% above prime.
4. In the event of the pupil being withdrawn from the school during the year, consideration will be given to refunding a portion of fees paid, providing due written notice is received by the Governing Body. Any such refund will be entirely within the discretion of the Governing Body.
5. I/we authorise the school to do a credit bureaux search on me/us and in the event of any school fees due by me/us not being paid. I/we authorise the school to inform any relevant credit bureau and have my/our name listed with them.
6. In the event that legal action in any form is taken against me for the recovery of any amounts due by me to the school, I shall be liable for and shall pay all costs as between Attorney and own client including collection commission and any tracing agents fees.
